



TxDOT trains employees to identify instances of human trafficking, and as recently as October 2022, TxDOTstaff the Gainesville Travel Information Center assisted two people who identified themselves as victims of human trafficking. victims had walked inside after running out of gas, and TxDOT staff connected them with law enforcement.


Through its Human Trafficking Work Group, TxDOT has also helped raise awareness through multiple education efforts. These include participating in #WearBlueDay on social media and in the office, and providing creating educational resources like flyers and wallet cards, listing common signs of trafficking, and how to report any suspicious activity while on or the job through iWatchTexas.

Texas consistently has the second highest number of calls to the National Human Trafficking Hotline (888-373-7888) every year. TxDOT has 12,000 employees spread out across the state. With that many people working together, we can make a difference.
