The Robert Lee ISD Board of Trustees held a regular meeting on Thursday, March 21, 2024. Those in attendance included board members Wes Washam, Linda Burns, Cole Bosworth, and Jose Morales. Board Erin Oleksiuk, members Beverly Sinclair, and Jeffie Roberts were absent.

The meeting was called to order at 5:01 pm by President Washam with a quorum of members present.


