Permit Report

Ricky Royall reported one townhome permit.

The council discussed the

approval of a new permit to replace existing manufactured homes according to ordinance 19-03 section 12 C with new Hud-code 2023 manufactured home for Asa and Heather Ruth. Gwen Dyess made a motion to approve the permit to replace the manufactured home one time with a newer one. She was seconded by Mike Bailey and the motion carried with a vote of 5 - 0.

The Mohler family has the flu and Mayor Gohman suggested tabling their item until the next regular council meeting. The council agreed.

The council discussed the revisions recommended by the subcommittee to the manufactured homes ordinance. After a lengthy discussion there were more questions that needed to be answered. Mike Bailey made a motion to table this item until the next meeting to get more clarification. He was seconded by Zach Davidson and the motion carried with a vote of 5 - 0.

Ricky Royall gave the council

an update on the progress of the Humble Pipeline Project. He said the contractors will be connecting to the main line next Thursday, March 23, 2023.

Ricky Royall discussed the new pricing for spraying the cemetery. It is \$9500 for a six-month weed guarantee and there is \$9200 budgeted. There will need to be a budget amendment for the remaining amount of \$300 for this budget yet. Ricky Royall did say they will start the spraying the first or second week of April. Zach Davidson made a motion to amend the budget for fiscal year 2022-2023 and start the spraying. He also said it will be needed to adjust the next fiscal year's budget to allow an 8-month period of spraying to start in
