Public Hearing! The Coke County Commissioners' Court held a public hearing on Thursday, August 8, at the courthouse in Robert Lee. The hearing was a result of a petition filed by Houston McGuire and Joe A. Luckett for the creation of an emergency medical and ambulance services district (ESD) for all of Coke County. The meeting began with Houston McGuire speaking to those in attendance regarding the need for an ESD. At this time, West Coke County EMS is handling emergency services for all of Coke County. With upwards of 30 calls a month, the handful of volunteers are spread very thin. Other speakers included Clay Avery with the Texas State Association of Fire and Emergency Districts who provided information concerning how an ESD is established; Luke Robbins, Coke County Appraisal District administrator; and Sherry Walker, Director of the Sterling County EMS. Following the hearing, Commissioner Henry Chisholm made the motion to grant the petition to create the district, fix the boundaries, and order an election to confirm the district's creation, which was seconded by Commissioner Donald Robertson. This item will be on the November general election ballot.


