ECCHD board meeting minutes told

The East Coke County Hospital District Board of Directors met for a regular monthly meeting on Monday, June 17, 2024, at 5 pm in the business office of Bronte Health and Rehab Center, 900 South State Street, Bronte, Texas. President Michael Bohensky presided over the meeting. Other board members present were Everett Bedford, Jerita Taylor, Gina McCutchen, and Kavin Tinney. Chief Financial Officer Johnny Mathis, Business Office Manager Susan Kight, and Director of Nurses Jessica Arthur were also present.

President Michael Bohensky called the meeting to order at 5 pm.

A quorum was established with all members present. Everett Bedford opened the meeting with a word of prayer.

There was no public present at the meeting.

The previous minutes were reviewed. Everett Bedford made the motion to accept the minutes as presented and was seconded by Gina McCutchen. The motion carried unanimously.

The board reviewed documents regarding the proposed tax abatement agreement with Gransolar Texas Five, LLC. Michael Bohensky will reach out to Judge Hal Spain for more pertinent information.

Tyler Cook presented the Administrator's Report to the board. He discussed financials

and monthly revenues. He states that upcoming resident activities will include the "Olympics" in the next few weeks. He also provided an update from Cary Services regarding A/C repairs and states that the HVAC contract covers the units. Cary Services will be providing a quote soon on a new walk-in freezer.

Discussion and possible amending of the employee medical insurance waiting period from 60 days to 30 days was tabled until the next meeting.

BHRC 4th of July plans were discussed. Events for the families, guests, and staff include a 9 am start to the Silent Auction for all to participate. This could include a resident, family member, staff member, or even a guest who just stepped foot into the facility for the first time. There will be fireworks bingo at 10 am for the residents, snacks and from 11 am to 1 pm for the residents and staff, a Connect 4 tournament at 2 pm, followed by rest time and visiting hours from 3 pm until 5 pm. The hot dog community cook out will begin at 6 pm with the baked goods auction from 7 pm until 8 pm to raise funds for the facility. The fireworks extravaganza will commence at 9 pm for the full town of Bronte.

Bailie Hillman and Thomas Cook presented Navigator Senior Living Management reports. Both have been in the facility for the last two days for

mock survey before getting ready for the State Annual Survey. Management is aware that the ice machine is cracked inside and is not producing enough ice. It is being looked at to replace with another ice machine. It was also noted that the kitchen oven has "old elements" and it is being looked at to replace with all electric appliances. Thomas Cook will review QIPP and Quality Measures and it will be discussed at the next board meeting.

Director of Nurses Jessica Arthur states that the facility currently has 37 residents. The facility admitted two residents since the last board meeting. There are currently 6 skilled residents.

The nursing department is looking for 1 - 2 night shift nurses, one full time day CNA, and PRN nurses to fill the gap during call-ins/vacation/etc. The facility Employee of the Month for June is Mya Flores, RN. Work will continue to be done on the mock survey today and tomorrow with Bailie Hillman and Thomas Cook preparing for the Annual Survey. The facility is also looking to get an outside therapy banner.

Chief Financial Officer Johnny Mathis presented his report and answered all questions from the board. The board discussed operating income for the upcoming year and the potential for increasing census.

The board reviewed all bank statements, petty cash reconciliations, and credit card statements.

There being no further business to come before the board at this time, Gina McCutchen made the motion to adjourn and was seconded by Kavin Tinney. The meeting adjourned at 6 pm.
